**NOTICE INVITING NOMINATION PAPERS TO ELECT THE EXECUTIVE

BEGINNING ON 1ST OCTOBER 2019**

In accordance with provisions of section-11 of the Act 13-(b) to the Trade Organizations Act, 2013 (11 of 2013): & 14-(b) for Women Chamber of Commerce and Industry Multan Division the Election Schedule for the term beginning from 1st October 2019, duly approved by the Executive Committee in its meeting held on 12th July 2019 is issued. The members are hereby invited to furnish their nomination papers for the purposes to contest annual elections for the eight seats of Executive Committee shall comprise of 50% from the corporate class members having annual turn over Rs.50 million or above. The 8% of the Executive Committee shall be elected by the General Body. The elected members of Executive Committee shall elect 3 x Women Entrepreneurs in its first meeting called to elect the office bearers:

1. The General Election shall be held by secret ballot during the month of Sep 2019 and members renewed till 31st March 2019 are eligible to cast the vote.
2. Right to vote shall occur only the members duly approved by the Executive Committee and has completed two years of valid membership as on the date of announcement of election schedule.
3. A member is entitled to propose or second only one nominee for the above said vacancies.
4. Neither postal ballot, nor proxy will be allowed.
5. A member, who desires to contest election of the Executive Committee, must give her contest in written as provided in the nomination form. Each nomination paper should accompanied by a nomination fee Rs.5,000 (Five thousands only) (refundable prior to publication her name in the ballot papers) in shape of Cash/Bank Draft/ Pay order in favor of Secretary General.
